# MEP October 2017 Report A Call elephant project

### **General:**

The Mara has had several heavy rains turning the area green but unfortunately, the grass is still very short. MEP is working on getting a weather station at HQ so that we can record more accurate weather information. This month we have been reacting to a number of security incidents in Loita, Mau and the Mara. The MEP intelligence team had a notable success when they led a Kenya Wildlife Service (KWS) ranger unit to arrest two suspects with 40 kg of ivory in Meru. This has been the second arrest in the last three months outside Narok County. We have been assisting our partners KWS, Narok County Government (NCG) and Kenya Forest Service (KFS) to bring a serious logging issue to light in the Mau Forest. We've provided intelligence gathered through aerial reconnaissance and submitted a report to the relevant people in each organization.

### **Fundraising:**

ESCAPE Foundation Executive Director Brian Kearney-Grieve got a written pledge from Christopher Parker from Oak Foundation for core operational costs. This is fantastic news and we will be presenting the full proposal before the end of November. We're also thrilled Margy McCormick has pledged to support an elephant collar and all activities to protect this elephant and their herd for the next three years.

## **Unmanned Aerial Vehicles (UAVs):**

On the 23<sup>rd</sup> of October, we received a no objection response letter to the KCAA application for the C.E.O. to operate two Mavic Pro UAVs. The last few items we need to complete is clearance from agencies in our areas of operation and updated dates of operation. This means that we are now able to continue with the UAV program to chivy elephants out of conflict.

### Research:

Jake Wall from Save the Elephants and Vulcan came to visit MEP for 12 days this month which was very productive. During this time, we achieved the bulk of our agenda and agreed on items to continue to work on. One immediate exciting development is that MEP and Mara Conservancy will have its own DAS chapter. This means we will be able to populate the system with MEP data directly and get automated reports from our efforts. The C.E.O. requested that Jake be the Chairman of the MEP Science Board.

### **Partnership Development:**

Chris Doehring and Jake Wall agreed to partner with us to set up DAS. This will happen in the next several weeks.

Trey Freshened who manages our Special Projects attended a drone training course with Brian Kearney-Grieve in Virginia with Expert Drones who MEP plans to partner with to develop the UAV project.

### **Security:**

The same gang that we recently reported had robbed Mararienta and shot the policeman in Aitong hit another four times in the last month. This level of activity, and the inability to catch them, is totally unacceptable and MEP will re-deploy our intelligence network to help. As one of the stakeholders in the Mara, MEP takes this issue seriously. Below is a table outlining their activities.

We sent the rapid response unit back into the Mau Forest and they have recorded a lot of human activity, including illegal logging, inside the forest and HEC with surrounding farmers. They followed a bull herd and a family group looking for collaring candidates.

On the 16<sup>th</sup> we responded to shots fired in Loita with a small armed team from KWS. They interviewed many herders in the forest and patrolled the areas where the shots came from.

From the 11<sup>th</sup> to the 17<sup>th</sup> we joined and provided aerial support to a joint operation in the Nyekweri Forest to stop illegal charcoal burning operations. We were successful with 27 suspects arrested.

### **Incidents sitrep**

Dead elephant on: 11/10/2017.

A dead elephant was found in Mara North Conservancy; the carcass was reported by MEP HQ team. The cause of death considered as human - elephant conflict, the raw cause was arrow wound. Elephant known as Courtney was one of Mara Elephant Project's most recent collared elephants. She was collared on October 29, 2016 in Olonkolin after she was found wounded by 11 arrows. She was in a harrowing attack by farmers after she and her herd had been actively crop raiding. Tusks were recovered and handed over to the KWS Ewuaso Ngiro station. Mike file number 20/17.


Ivory recovered and arrest: 22/10/17.

The above table is constructed from data in the WILD app which has been manually compiled by Tracking Manager Wilson Sairowua. We are still having issues with WILD not being able to export tracks and tabulate patrol data; however, we can still better rate ranger teams and keep on top of their movements so we still find WILD useful operationally. We are looking at options to collect ranger data which goes strait onto DAS using Garmin InReach devices and then generate reports from our data.

### HEC:

This month we only experienced a few HEC incidents. These were related to elephants in settlements, crop raiding recently planted maize farms, and disturbing livestock herds.

### **Meetings:**


Jake Wall and Nic Elliot from the Mara Lion Project met at the predator hub on the 24<sup>th</sup> to discuss a scientific collaboration.




On the 14<sup>th</sup> Wilson hosted a training course at MEP HQ for the management of MNC, Olchoro, and Naboisho on the WILD app.

### **Elephant Tracking:**

KWS gave us permission to collar two elephants in the Mau Forest. As mentioned in the incidents situation report we lost elephant Courtney. We have not been able to monitor all the elephants by air this month but we did visit a few during other operations. This month we are presenting the 3<sup>rd</sup> quarter SARF analysis. One notable movement was Chiri who had a 40% increase in range last quarter when she went to Loita and then back to Siana.
